The Board and City staff are working hard to make those experiences more valuable and memorable in the days, months and years ahead.





OUTLOOK

Riverside is more than an address. It's a place to live, work and raise a family. Want proof? Check out the results of our 2010 resident and business survey conducted

by the ETC Institute on behalf of the City. When compared with other communities across the country and around the Kansas City Metro, Riverside was rated significantly above average for

quality of life and major city service areas. Every household and business had the opportunity to respond. And more than 400 residents and 50 businesses took part.

2010 ETC SURVEY

Importance Satisfaction Rating

There are two key criteria for making decisions in Riverside. One: Target resources toward services of the highest importance to citizens. Two: Target resources toward services where citizens are least satisfied.

The Importance Satisfaction Rating is an analysis of the data collected through the survey. It combines these two criteria to develop a list of the top priorities for the City in the coming years. Results are reflected below.

Top future priorities:


1. Enforcement of codes and ordinances
2. Overall flow of traffic and congestion management
3. Effectiveness of community planning/development
4. Maintenance of City streets/buildings/facilities
5. Overall quality of water/sewer utilities

Major Findings

Quality of Life:

Eighty-nine percent of Riverside residents were satisfied with their overall quality of life. This significantly exceeds the national average of 80 percent, and is an increase from 85 percent reported in the 2008 Riverside survey.

Overall Satisfaction:






Nationwide Highs:

Riverside set new national standards in value received for tax dollars, enforcement of local traffic laws, visibility of police in retail areas and City efforts to inform on local issues.

Areas to Emphasize:

The major areas residents believe are most important for the City to emphasize over the next two years are flow of traffic and congestion management; maintenance of City streets, buildings and facilities; and effectiveness of community planning and development.

Confidence and Precision

The results of a random sample of 400 households and 50 businesses indicate a 95 percent level of confidence with a precision of at least +/- 5 percent. In other words, if the survey was conducted 100 times, 95 times the results would be the same or within 5 percent.



HIGHLIGHTS AND AWARDS

All-America Finalist

The City of Riverside was named as one of 27 finalists in the 2010 All-America City Award program, produced by the National Civic League. The City competed with communities throughout the United States for one of 10 All-America City Award designations.

While Riverside was not named to the prestigious list of 10, the City did receive some All-America recognition. The “My Riverside” video won best All-America Story in the program’s multimedia contest. The video featured residents, business owners and city employees sharing the reasons they choose to live and work in Riverside. The video also took

third place in the People’s Choice contest, receiving more than 10,000 votes on YouTube.

Protect and Serve

Members of Riverside’s emergency radio system advisory committee were awarded the Missouri Municipal League’s 2010 Civic Leadership Award. The committee was formed to evaluate a recommendation by the Department of Public Safety

to replace the City’s aging emergency radio system. The committee learned that the existing radio system was past its serviceable life and provided unreliable communication. The committee agreed that while the fix was expensive, the ability of public safety personnel to communicate is basic to providing a safe environment for those who live and work in Riverside. The committee is comprised of Cy Houston,

Beverly Allen, Jim Dwyer, Bob Bayless, Mary Churchill, Pat Casey and Alderman Aaron Thatcher.

Clarence M. Kelley Award

Department of Public Safety Director Chief Greg Mills received the 2010 Clarence M. Kelley Award from the Kansas City Chapter of ASIS International. The prestigious award is presented annually to a criminal justice executive who is an excellent administrator, proactive in their approach and dedicated to improving the criminal justice system.

Officer of the Year

Detective Pete Edlund, who retired from the Riverside Police Department in the summer of 2010, received the Crime Stoppers 2010 Officer of the Year Award.





This award is presented to an outstanding officer with an exemplary work history and ongoing awareness of problems facing the community.

Upstream Appeal

The City of Riverside's Branding Campaign, developed in partnership with Trozzolo Communications Group, received a Silver Award from the PRSA Greater Kansas City Chapter's PRISM gala.

The new brand, which launched in early 2010, was a reflection of the many changes that occurred across the community in the past 10 years and aims to promote Riverside as a vibrant, fresh and progressive place to live, work and visit.

Eventful City

The City kicked off fireworks season with BLAST 2010, a pre-Independence Day celebration at the intersection

of Gateway and Vivion. Through the Tourism Tax Fund, the City continued to provide support to popular annual events including Riverside Riverfest, Kansas City Scottish Highland Games & Celtic Festival, the Midwest All Truck Nationals and a variety of other car shows and festivals. And to carry on a tradition of reaching out to residents during the holiday season, the City hosted Shop with a Cop/Firefighter, the Senior

Holiday Lunch at the Community Center and the Holiday Lighting Ceremony at the Welcome Plaza.


Community Centered

The Community Center launched a series of new programs this year. The Reading Program provides an opportunity for Riverside kids to enhance their reading skills through small group learning. 

CAPITAL IMPROVEMENTS

To assist with planning, a five-year comprehensive capital improvement plan was developed to fund major projects including streets and bridges, infrastructure maintenance, community development, public facilities, parks and equipment – all the things that make Riverside upstream from ordinary.

CAPITAL IMPROVEMENTS

Key Projects

Argosy Casino Parkway North

The second phase of the Argosy Casino Parkway project was completed. The project included adding new roadway, reconstructing existing roadway and adding a bridge over the BNSF railroad. This project improves access to EH Young Park and the Argosy Casino Hotel and Spa.

Vivion Road West

Vivion Road from QuikTrip to Aspen Drive was reconstructed. As part of the project, a new crossing over Jumping Branch Creek was created and sidewalks were added.

Annual Street Maintenance Program

The City continued to address and complete needed improvements to streets, sidewalks and trails. This year's projects include curb and gutter work along High Drive, paving the Line Creek trail from Woodland to St. Joe, and curb, gutter and an asphalt overlay in the City Hall parking lot.

Renner Brenner Park Playground

The new playground opened in Renner Brenner Park. The playground was moved from the bottom level by the skate park up to the main level of the park near the shelter houses.

DETAILS

FINANCE

The fiscal year 2010-11 budget was created with citizen input plus a five-year capital improvement plan – with an emphasis on funding high-priority programs through a fiscally responsible approach.

For the fourth consecutive year, Riverside was awarded the Certificate of Achievement for Excellence in Reporting for the City's 2009 Comprehensive Annual Financial Report (CAFR), which all cities are required to complete.

More than the recognition it garnered from the Government Finance Officers Association, the report is a testament to how Riverside's strength and stature are viewed by bond-rating entities and the financial markets.




FINANCE

Revenue

Total budgeted revenues of \$24,619,400 are \$4,714,200 lower than the 2009-10 budgeted revenues of \$29,333,600. Reimbursements from other entities for construction projects are responsible for the majority of the change in revenues.


The following graph displays total budgeted revenues, excluding inter-fund transfers.



Expenditures

After reviewing budgets from each City department, the Board of Aldermen approved expenditures totaling \$43,995,813 for the 2010-11 fiscal year, a nearly 18 percent decrease compared to fiscal year 2009-10.
